The report of the committee, recognizing that a higher domestic wheat price is not in itself sufficient to meet the problem, also suggested that deficiency payments be considered, that Canada seek inclusion of agriculture as a specific item at the next round of GATT talks, and that Canada continue to strive for a new international grains agreement.

I am pleased to have been part of this committee which was formed as a result of my Private Member's Motion of last December. The entire process leading up to the report demonstrates that back-bench Members of Parliament can have meaningful input, input which can and does influence government policy.

# **AGRICULTURE**

FARM FINANCE REVIEW PANELS—CALL FOR ESTABLISHMENT

Mr. Vic Althouse (Humboldt—Lake Centre): Mr. Speaker, in spite of the worsening farm crisis brought on by falling world grain prices, the House has yet to see action taken by the Government on its promise to provide farm finance review panels. After the election, we saw the so-called Grey-Bruce experiment. A report was presented but no action was taken. Prior to Christmas the Minister of Agriculture (Mr. Wise) said that he would present legislation with teeth, prior to Christmas, yet again we saw no legislation. In February the Minister of Finance (Mr. Wilson) presented his Budget and promised farm debt review panels, yet no legislative proposals were made and no action taken.

The end of April saw the Prime Minister (Mr. Mulroney) enter the Conservatives' phoney war against farm debt with a promise that farm debt panels would be in place before the end of June. No legislation has been presented and no action has been taken. Today a committee recommended a \$10 per bushel price for domestically consumed wheat. Will this recommendation be acted upon any faster than the oft-repeated promise to establish debt review boards?

In a municipality where jobs are scarce, I deplore the fact that Pointe-au-Chêne men and women cannot hope to get this interesting job which might support another needy family. Mr. Speaker, I hope the Minister and the Canada Post Corporation president will meet with the union and abolish this conflict of interests practice which sullies the reputation of the corporation and therefore does disservice to postal employees and the members—

## SEQUEL TO PRIVATIZATION OF DE HAVILLAND

Mr. Bill Attewell (Don Valley East): Mr. Speaker, the Government remains committed to the process of the privatization of Crown corporations which are not essential to the achievement of public policy. Several months ago de Havilland Aircraft was sold to the Boeing company of Seattle. Canadians will recall the doom, gloom, and fear tactics used by the Liberals and the NDP about the loss of jobs. As we predicted, the new owners have instilled long-term confidence in de Havilland and new orders are now on the upswing.

Three major sales totalling \$410 million and up to 46 Dash 8 turboprops were made this week by de Havilland. Richard Barton of Time Air of Lethbridge, Alberta, whose recent order was worth \$110 million, said:

We view the company with more confidence with the Boeing reputation behind it.

Thanks to the healthier order book, 4,850 workers at de Havilland are now secure. More jobs will be created thanks to Boeing's world-wide sales network.
