LATE QUEEN UNDOED THEIR WORK

London, July 14.—Militarism represents the Church of England Burial, Funeral and Mourning Reform Association are soon to visit the United States to preach the gospel of the association, which will lead the nation.

He is to be here for such a period, however, that he has decided to become a full-fledged American. He will leave for his home at Toronto in a few days, and will return in the fall with his family.
