(b) (i) The cost for the delivery service is included in the selling price of the stocked item. (ii) The costs for this service are as follows: A. small van with driver—\$15 an hour. B. Large vehicle with driver and helper—\$23.50 an hour. C. Tractor-trailer—at negotiated rates.

- 2. The trucks owned are: 29 light trucks; 18 medium trucks; 4 heavy trucks; 2 tractor-trucks; 2 trailers. These trucks are located in: Vancouver; Edmonton; Toronto; Ottawa; Montreal; Halifax; and Goose Bay. There are no leased trucks.

IMMIGRATION ACT, 1976

AMENDMENTS TO IMPLEMENT CHANGES IN IMMIGRATION POLICY

The House proceeded to the consideration of Bill C-24, respecting immigration to Canada, as reported (with amendments) from the Standing Committee on Labour, Manpower and Immigration.
