

75. Resolved, That a sum not exceeding five-sixths of Eight thousand dollars be granted to His Majesty, for Miscellaneous—Canadian Associated Press, for the year ending 31st March, 1919.

76. Resolved, That a sum not exceeding five-sixths of Six hundred thousand dollars be granted to His Majesty, for Miscellaneous—To provide for the administration of the Business Profits War Tax Act, 1916, and the Income War Tax Act, 1917: Appointments for the purpose may be made without reference to the provisions of the Civil Service Act, for the year ending 31st March, 1919.

77. Resolved, That a sum not exceeding five-sixths of Ten thousand dollars be granted to His Majesty, for Miscellaneous—Grant to assist the Canadian Association for the Prevention of Tuberculosis, for the year ending 31st March, 1919.

78. Resolved, That a sum not exceeding five-sixths of Two thousand dollars be granted to His Majesty, for Miscellaneous—Grant to the Canadian Handicraft Guild, for the year ending 31st March, 1919.
