- 10. The difficulty experienced in obtaining a clear title in each case on account of numerous encumbrances and reservations affecting the lands in question. It was finally deemed advisable to expropriate in order to vest title in the crown, free from all encumbrances, and thereby permit the transaction to be completed in so far as the owners mentioned in answer to No. 2 are concerned.
