HOUSE OF COMMONS

METHOD OF PROMOTION IN PROTECTIVE SERVICE

On the orders of the day:

Mr. A. J. Brooks (Royal): I should like to ask the Minister of Veterans Affairs a question. This may not come directly under his department but I think the minister will be particularly interested. My question has reference to promotions in the protective service of the House of Commons. In making promotions in the protective service is preference given in the matter of promotion to veterans with active service in the first and second world wars over members of the protective service who have had no military service? Does the time spent in military service count towards seniority in the protective service?

Hon. Hugues Lapointe (Minister of Veterans Affairs): Mr. Speaker, as the hon. member pointed out, this matter does not come directly under my department. The members of the protective service of the House of Commons are employees of the House of Commons. I am not positive but my understanding is that although they are employees of the House of Commons they enjoy the same privileges as other civil servants. My understanding of the veterans preference in the civil service is that preference is given to veterans with respect to entering the public service but that so far as promotional competitions within the service are concerned the veterans preference does not apply any more. I believe that is the position with regard to the civil service.

As to the second part of the question, as to whether military service should count in determining seniority in the protective service, I shall have to inquire about this matter. But there again I should like to point out that under the Civil Service Act military service does not count in determining seniority but it can be counted for superannuation purposes, and the date of seniority depends upon the date of entry of the servant into the public service.
