VANCOUVER-POSSIBLE EVICTIONS FROM VETERANS HOUSING PROJECT

On the orders of the day:

Mr. G. L. Chatterton (Esquimalt-Saanich): I should like to ask a question of the Postmaster General. Being responsible for C.M.-H.C., is the minister aware that certain of the members of the Fraserview veterans tenants and home owners association have today received letters from the local office of the Central Mortgage and Housing Corporation advising that tenants may remain if they send in a signed acceptance of the increased rents and pay the current rent to October 1; and can the minister say whether those who do not do so will be forcibly evicted?

Hon. J. R. Nicholson (Postmaster General): Mr. Speaker, I think that is a question for the order paper.

An hon. Member: That is effective October 1.

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, I rise on a point of order. That is not a matter for the order paper. In spite of the fact that the Minister of Labour thought September had 31 days, today is the second last day of this month and this is a matter of great urgency to these people. There is only 24 hours in which they can possibly have an answer. I submit the government has played around with this question long enough and that these people have the right to know now what the answer is.

Some hon. Members: Order.

Mr. Nicholson: Mr. Speaker, the government has not played around with this matter for a long time. The government has made a decision.

Mr. Diefenbaker: What is it?

Mr. Nicholson: The time limit does not expire until midnight tomorrow night, and already out of a total of 600 over 500 of the tenants have acquiesced in this decision. There is still time for some of the others to fall, could the minister inform us as to reach a conclusion, and no decision can whether the corporation intends to extend very well be taken, as the right hon. gentleman should know, until that time expires.
