I understand the coal operators made certain representations to the Canadian Pacific Railway to the effect that this increase of 25 cents a ton in freight rates would jeopardize their Japanese contracts, and they asked for six months' delay in order to make certain proposals to the railway for improving the whole situation and the turn around at Vancouver. The Canadian Pacific Railway has acceded to this request and has decided not to put the increase into operation for another six months.

NOVA SCOTIA—SUBVENTIONS ON COAL SOLD TO ONTARIO HYDRO

The regulations applicable have no expiry date and will continue, as in the past, to provide assistance on the movement of Nova Scotia coal to consumers in the competitive area, including the Ontario hydro commission.

REQUEST FOR INCREASED SALARIES FOR PROTECTIVE STAFF

The cyclical pay review of the civil service group "D" is now being worked on. This would mean, after all the necessary steps have been taken under the Civil Service Act by way of interviews with the appropriate associations and so on, that a decision concerning pay changes affecting civil servants in group "D" would be announced by about July 1. The usual practice is that the protective staff and certain other groups in the House of Commons would be dealt with immediately afterward in relation to that group "D" examination. I might add that any pay increases in group "D" would be retroactive to October 1, 1964.
