- 3. If so, what decision has been made requiring the use of such a gun or a similar weapon in the seal hunt for the 1969 season?

# Mr. E. F. Whelan (Parliamentary Secretary to Minister of Fisheries): 1. Yes.

- 3. Regulations will not require the use of such a gun or similar weapon during the seal hunt in 1969; further testing is felt necessary.

#### \*WHEAT DRIED IN ELEVATORS

#### Question No. 1,150-Mr. Diefenbaker:

- 1. What is the estimated number of bushels of wheat that have been dried in elevators or on the farm (a) in line elevators (b) in government elevators at the Head of the Lakes (c) by farm producers in (i) Saskatchewan (ii) Alberta (iii) Manitoba, in each of the months November and December, 1963, and to the latest date available in January?
- 2. How many bushels have been dried during said months in interior government elevators?

# Hon. H. A. Olson (Minister of Agriculture): Mr. Speaker, the reply to this question is as follows:

- 1. (a) No information is as yet available on the amount of grain dried at line elevators;
- (b) There are no government elevators at the head of the lakes;
- (c) This information is not available on a monthly basis. As of January 3 it is estimated that the following quantities of grain have

Hon. Gérard Pelletier (Secretary of State): I am informed by the C.B.C. as follows: The C.B.C. looks most favourably upon establishment of a C.B.C. television station in Saskatoon and filed an application for such a station some time ago. However, the C.B.C. has asked the Canadian Radio-Television Commission to hold this application in abeyance pending the outcome of current negotiations for the purchase of CHAB-TV, Moose Jaw and CHRE-TV, Regina, which could affect the total C.B.C. service in Saskatchewan.
