## FINANCIAL ASSISTANCE TO WEST COAST NATIVE FISHERMEN—REQUEST THAT MINISTER ATTEND MEETING

**Mr. Frank Howard (Skeena):** I wish to direct my question to the Minister of Indian Affairs and Northern Development. Incidentally, I congratulate him on attaining a batting average of 33 per cent in his required roster appearances this week. I asked his colleague, the Minister of Fisheries and Forestry, the other day a question with respect to the situation of at least 100 native Indian fishermen who will be put out of work. The Minister of Fisheries told us there was a finance plan available under the Indian Fishermen's Assistance Board. Now that the minister is here, can he explain what this program is and tell us when it will come into effect?

**Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development):** First, I should like to congratulate the hon. member on his candidacy; it is too bad he will not get 33 per cent of the votes, but I wish him the best of luck. As far as Indian fishermen in British Columbia are concerned, I am well aware of the situation to which he refers. I know that some fishing companies are cutting down their fleets. We have some funds available. I have sent some of my officials to the area; we shall try to assess the situation and adjust our financial program so as to assist as many Indians as possible to stay in business as good fishermen.

**Mr. Howard (Skeena):** Might I say that my objective is not 33 per cent; it is much higher than that. Inasmuch as the Minister of Fisheries has refused an invitation to attend a meeting called by the North Coast District Council in Prince Rupert, for the 25th of this month to deal with this matter, will the Minister of Indian Affairs and Northern Development be prepared to attend that meeting and speak to the people personally?

## PLANS FOR PROVISION OF SUMMER EMPLOYMENT FOR STUDENTS
