NATURAL GAS—POSSIBLE SALE BY PANARCTIC TO UNITED STATES—CONTROL OF PIPELINE

Having regard to the statement made by the President of Panarctic Oils Limited, of which the government of Canada is a substantial shareholder, to the effect that Panarctic intends to sell on the United States market at least one trillion cubic feet of gas annually, which is equal to the total volume of current Canadian gas consumption, would the minister inform the House whether this intention is shared by the Canadian government?
