



Part of Crescent Beach's Two-Mile Bathing Beach

The water is exceedingly warm and clean and the beach perfectly safe, even for the smallest kiddie. Careful management prevents any rowdiness on this beach; in fact, throughout the whole community.

In addition, there is Sailing, Canoeing, Motor Boating, Hill Climbing, Berrying, Picnicing, Clam-baking, room for golfing, and countless other out-of-door sports. A well managed hotel provides excellent accommodation for transient guests.

OTHER ADVANTAGES

There is lots of elbow room at Crescent Beach. Only one summer cottage is allowed on each lot and these lots are each fifty feet wide by one hundred and twenty feet long to a lane. Also there is plenty of level space at Crescent Beach—no hill obtrudes itself, and the railway tracks are far back from the beach.

Small stores supply campers with groceries, meat, and milk, while water is piped to the rear of each lot. Excellent anchorage for boats is afforded at the mouth of a river which empties into the salt water close by. Those who care for deep water bathing may find it near this part of the two-mile beach.

COSTS LITTLE TO LIVE HERE

For a small sum, a very reasonable sum, splendid sites can be purchased on good terms, upon which neat little summer homes or tents may be erected. It need not cost more, in fact, as much, to live at Crescent Beach for the summer as it does to live in the dry, hot, noisy city.
