*Foster, Hon. G. E.* (North Toronto)—10033.

*Oliver, Hon. Frank* (Minister of the Interior) 10408.

Arrangement was made with a view of introducing pioneer settlement into that particular tract of the Peace River

Bad policy to lock up land as in this case—10412. No evidence that the company had made any effort to bring in settlers, but shown that they are trying to sell their interest in it and make money—10414. The department's notice of cancellation—10415.

Motion in connection with the seizure of the *Carlotta G. Cox*—Mr. Sloan—3934.

*Brodeur, Hon. L. P.* (Minister of Marine and Fisheries)—3980.

Treaty negotiations between Great Britain and Japan; no question of Japanese sealing in Behring Sea at that time—3980-81. Why Canada adhered to the Japanese treaty—3981-82. Seizure of the *Carlotta G. Fox*—3983-84.

*Fielding, Hon. W. S.* (Minister of Finance)—3978.

Canada and the Empire—3978-79. Adaptability of the British constitution to changing conditions; all Canadians proud to belong to the British Empire—3979.

*Laurier, Rt. Hon. Sir Wilfrid* (Prime Minister)—3971.

Canada's position in relation to the mother country satisfactory; Canada's treaty-making power—3972. The new conditions on the Pacific Ocean—3973. Unsatisfactory position of British pelagic sealers on the Pacific; U. S. claims—3973-74. Advantages enjoyed by Japanese over British sealers; restriction on sealing necessary; matter engaging attention of government—3974.

*Monk, F. D.* (Jacques Cartier)—3974.

Difficulty of reconciling Canadian and Imperial interests; Canada has not brought sufficient pressure to bear in order to secure fair treatment in negotiation of treaties—3974.
