WITHOUT APOLOGUES TO THE GREAT REPUBLIC. Full Text of Mr. Taylor's Bill to Prohibit the Importation of Alien Contract Laborers

The bill introduced in the House of Commons by Mr. George Taylor, the member for South Leeds, to prohibit the importation of alien contract labor is exciting great interest

As stated in the World yesterday, the special committee recommended to the House that it should be referred to the committee on the measure and that thereby the tender susceptibilities of our republican neighbors would be deeply wounded

The bill is modeled upon and is along the same lines as the proposed Labor Law now in force in the United States, and it is difficult to understand why it is not more generally approved in this country

It will be noticed that the bill prohibits not only the importation of alien contract labor, but also the importation of alien contract laborers who are not in possession of a passport

As was shown in the debate when the bill came up in the House, the measure is not only in the interest of the United States, but also in the interest of the Dominion of Canada

The text of the bill is as follows: "1. From and after the passing of this act, it shall be unlawful for any person, company, partnership or corporation in any manner whatsoever to employ or contract with any alien or foreigner to perform labor or service in any way connected with the operation or migration of any alien or alienist, unless such alien or foreigner is in possession of a passport
