CRIMINAL CODE

AMENDMENT RESPECTING ATTEMPTED SUICIDE

Prud'homme Marcel (Saint-Denis) moved for leave to introduce Bill C-173, to amend the Criminal Code (Attempted suicide).

Some hon. Members: Explain.

Mr. Prud'homme: Mr. Speaker, the purpose of this deeply humanitarian bill is to make it so that attempted suicide will no longer be considered an offence under the Criminal Code but will be relegated, as it should be, to the field of medicine.

Section 213 of the Criminal Code now reads as follows:

Every one who attempts to commit suicide is of an offence punishable on summary guilty conviction.

Motion agreed to, bill read the first time and ordered to be printed.

Hon. Robert K. Andras (Minister without Portfolio): 1. Public housing projects financed under the federal-provincial partnership arrangements of Section 35A, NHA, are owned and administered jointly by the two levels of government.

The federal government does not participate in the actual administration of public housing projects, low rental housing projects [Mr. Speaker.]

for hon. members to explain to the House and student housing projects financed under Sections 35D and E, Section 16 and Section 36B of the Act. These projects are administered in accordance with the requirements of the NHA by the owners.

> 2. The arrangements with provinces may vary within the terms of the NHA to suit local requirements.

4. The urban renewal policy, including the administrative arrangements, is currently under review.
