# Inquiries of the Ministry

Hon. Otto E. Lang (Minister of Manpower and Immigration): Mr. Speaker, the question is rather broader than the scope of the responsibilities of this department.

Mr. Noble: Mr. Speaker, I have a supplementary which I should like to direct to the Prime Minister. Can the Prime Minister give the House any information regarding reports that there is a guerilla training camp operating in northern Quebec?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, directing the previous question to me, I can answer as the minister has that this is not a question of immigration, I understand, but a question of returning Canadians. Indeed, if they are suspect as the hon. member suggests, it would not be a question for the Minister of Manpower and Immigration but rather a question for the Solicitor General. I would appreciate it if he would also direct the latter question to the Solicitor General who would know more about it than I.

Mr. Noble: Mr. Speaker, I should like to direct a further question to the Prime Minister. Perhaps he will remember that when he was Minister of Justice I directed this question to him. Would the Prime Minister not make an investigation as promised when I put the same question to him in March, 1968, with regard to a guerilla training camp in northern Quebec?

Mr. Trudeau: Would the hon. member read my answer at that time? I do not remember it exactly.

In view of the serious problems in Quebec, does the federal government intend to amend the immigration laws so that we do not tolerate the entry into this country of known anarchists and revolutionaries from other countries?

Hon. Otto E. Lang (Minister of Manpower and Immigration): The government has under consideration the whole question of our present immigration laws and procedures, and further comment on these subjects will be put before the House in this session, as hon. members know from reading the Speech from the Throne.

Gérard Pelletier (Secretary of State): Mr. Speaker, in accordance with the Broadcasting Act, it is not the responsibility of the Secretary of State to issue such guidelines but that of the Governor in Council, the Cabinet in other words. I do not think any such action is being considered at this moment.
