ANNOUNCEMENT OF AGREEMENT TO PROVIDE PROTECTION BY FILING OF INTERNATIONAL APPLICATION

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): Mr. Speaker, I should like to inform the House that on June 19 Canada signed a Patent Co-operation Treaty at the conclusion of a diplomatic conference held in Washington, D.C., in which 77 countries participated. The purpose of the treaty is to simplify the filing of patent applications on the same invention in a number of different countries. Currently, when inventors and businessmen attempt to obtain protection on the results of their research, they must apply in all the countries where they want patent protection. Under the new treaty, an applicant would be able to file an international application in the patent office of his own country, and the applicant would indicate the countries in which he desired protection.

The treaty is subject to ratification, and it may be some time before enough countries have ratified to bring it into force. We hope it may provide savings to Canadian investors and businessmen and relieve some of the examining burden on the Canadian Patent Office
