PLANS RESPECTING PROVISION OF SUMMER HOSTEL FOR TRANSIENTS

Mr. Gérard Laprise (Abitibi): Mr. Speaker, I wish to ask the hon. Secretary of State a question concerning his hostel program for transient youth. Could he tell the House whether he has met with Quebec authorities with regard to this hostel program for transient youth which, it would seem, is exclusively under provincial jurisdiction since it is connected with education?

Hon. Gérard Pelletier (Secretary of State): Mr. Speaker, we have not had a special meeting devoted to the matter of young people's hostels, but we have had meetings where this matter was brought up. The government of the province of Quebec has agreed, as we were agreed before, that hostels for transient youth providing studying, education and folklore training facilities, etc., may and in fact do come under provincial authority at the present time. But the provinces, Quebec included, also admitted that federal authorities are responsible for setting up shelter-type hostels where the stay is limited to one or two nights and which would allow all young Canadians to travel across the country.
