DELAY IN NEGOTIATIONS BETWEEN LOCOMOTIVE ENGINEERS AND RAILWAYS—INTERRUPTION OF RAIL SERVICE

Mr. John L. Skoberg (Moose Jaw): Mr. Speaker, I ask leave, seconded by the hon. member for Fraser Valley

Rail Service Negotiations

West (Mr. Rose), to move the adjournment of the House under Standing Order 26 for the purpose of discussing a specific and important matter requiring urgent consideration, namely, the interruption of rail service on the Canadian National and Canadian Pacific caused by unwarranted delays in the negotiations between the Brotherhood of Locomotive Engineers and the railways, the four-month delay before a conciliation board was appointed by the Minister of Labour, the six-month delay before the said board made its report, and the failure of the board to make recommendations on all but two of the more than 20 issues referred to it, and the urgent need to seek an immediate settlement of the dispute in view of the serious effects on the economy of a railway strike affecting the movement of grains, perishables, minerals and other products.

Mr. Speaker: The hon, member for Moose Jaw has given the Chair the notice required under Standing Order 26. Without going into the details of the form of the notice given, I think I should indicate to the hon, member for Moose Jaw that both the notice as given to the Chair and the statement as presented by the hon, member to the House might perhaps be considered as going somewhat beyond the very limited terms of reference allowed to the hon, member by the terms of Standing Order 26, which invites an hon, member to merely state what the matter is that he wishes to be considered by the House. In any event, I can assure the hon, member that I have given the matter very serious consideration.

It is obvious to the House, I am sure, that the hon member has raised a very important matter which conceivably might require further consideration at some time in the future. After carefully perusing the hon member's motion, I should like to suggest that the events referred to are in the nature of a developing situation in that the two parties are still, as I understand it, discussing the issue. I do not feel that the Chair can assume that these negotiations are in such a state as to require a debate in the House at the present time under the provisions of Standing Order 26. It should also be observed that if leave were granted to allow a debate under Standing Order 26 at this time, under our rules it would be impossible for the hon. member, or any other hon. member, to raise this issue again during the current session under the terms of Standing Order 26.

Bearing all these considerations in mind, I feel that the motion proposed should not be allowed at this time.
