OFFICIAL LANGUAGE TRAINING

Question No. 2,562—Mr. Herbert:

1. What are the total costs included in the 1975-76 Estimates of the Department of External Affairs for language training?
2. How are such costs divided between (a) salaries of personnel receiving instruction (b) salaries of instructional staff (c) additional or supplementary services to be purchased from the Public Service Commission (d) other costs?

Mr. Herb Breau (Parliamentary Secretary to Secretary of State for External Affairs): 1. \$746,200.

2. (a) Replacement man-years and salary moneys for those on language training are provided separately by Treasury Board, and therefore are not included in direct training costs. (b) Instructional staff salaries will amount to \$212,000 primarily in connection with our overseas language programme. (c) \$351,600 is targeted for supplementary services from the Public Service Commission in the form of monitors, pedagogical advisors and special programmes. (d) \$182,600 has been budgeted to cover items such as software, equipment, travel and administrative salaries in the Official Languages Unit.
