As far as I am concerned, and I think I can commit the cabinet as well—assuming that the important thing is to have a decision, and the mayors are going to let me know in a few minutes—I believe I can give the hon. member the assurance that I shall do my utmost to provide an answer within the next two or three months, as I just said.

BANK FUNDING FOR SMALL BUSINESS DEVELOPMENT BOND PROGRAM

Hon. Jake Epp (Provencher): Madam Speaker, I would like to direct my question to the Minister of Finance but, in his absence, I will direct it either to the Prime Minister or to the Minister of State for Finance. While the November 12 budget seriously eroded the effectiveness of the Small Business Development Bond, it at least gave some hope to owners of small businesses and farmers that there might be some relief from high interest rates. Could the minister explain why it is that while that budget provision is now in effect, the banks of Canada have cut off all funds for Small Business Development Bonds?

Hon. Pierre Bussières (Minister of State (Finance)): Madam Speaker, the hon. member is making very serious allegations when he says that Canadian banks have definitely cut off all funds for Small Business Development Bonds. I

think that the situation should be monitored very closely and the Minister of Finance will get in touch with representatives of the banking institutions to check these allegations, and should they turn out to be true, find out the reason for such behaviour.

REQUEST FOR REPORT

Hon. Jake Epp (Provencher): Madam Speaker, I wish those allegations would be checked. If the Minister of State for Finance checks with the banks he will find that, for instance, as of February 10 the Royal Bank withdrew those funds. Canadians have gone to some expense. They have retained accountants to find out whether they are eligible for Small Business Development Bonds. Time has been spent but, more important, this is another aspect of the budget which has just gone by the boards. It is another discredit to the Minister of Finance.

When will we have an answer? Is the Small Business Development Bond in effect? Is there funding and, if there is not, will the government give Canadians an answer tomorrow? Is there money for Small Business Development Bonds?

AIRPORTS

MONTREAL—ESTABLISHMENT OF ENLARGED ADMINISTRATIVE AIRPORT ZONE
