### OFFICIAL LANGUAGES

**Mr. Guy H. Arseneault (Restigouche—Chaleur):** Mr. Speaker, last February 15 I made some comments in this House concerning the finance ministry's provision of brochures, in one official language only, to residents of my riding concerning the goods and services tax. On May 1, I again received a letter from a constituent complaining that he had received government information concerning the GST in one language only.

The same problem also occurred throughout the Acadian peninsula where a number of people received a GST English-only publication from the Government of Canada.

I have to remind the Minister of Finance that the residents of the riding of Restigouche—Chaleur are bilingual and that New Brunswick is the only officially bilingual province in Canada.

My constituents expect bilingual services and the government must see to it that they do.

How much longer must New Brunswickers wait until the federal government offers them services in both official languages?

Parliamentarians and all persons who respect human rights and abhor racism join with Jews to lament and protest such anti-Semitic acts which create fear of another holocaust and bring shame on us all.

As Canadians we must not be complacent. In 1987, B'Nai Brith recorded a 57 per cent rise in acts of bigotry against the Jewish communities. In Toronto alone there were 39 reports of harassment of Jews. Six desecrations
