

NOW 215,782 CARS IN NEW YORK CITY

And 682,894 Motor Vehicles
Are Registered in the
Empire State.

Albany, New York.—New York state registered 682,894 motor vehicles, exclusive of motorcycles, last year, a gain of 19 per cent over the previous year, according to figures given out today by Secretary of State John J. Lyons. This is a car to every fifteen residents.

Passenger types increased 17 per cent, during the year, reaching a total of 524,257; commercial cars numbered 128,394, a 29 per cent gain; chauffeurs reached a total of 216,811, or 35,179 more than in 1931. The state's motor vehicle year concluded on Jan. 21. Receipts to the state's automobile bureau amounted to \$9,000,000. New York city is shown with 215,782 cars, or \$7,831 more than a year ago, a 31 per cent increase. The metropolis has 149,222 passenger cars, 11,618 omnibuses, 52,128 commercials, 1,598 dealers, 121,394 chauffeurs, and 9483 motorcycles.

tempted to influence him in arriving at judgments in cases that came before him since he was appointed to the position about six years ago. The crown attorney was the only one he had consulted or who had interviewed him in reference to fines, punishment or disposition of cases which came before him during that time. He denied that he was opposed to the O. T. A., but admitted he considered two of the clauses of it faulty. One was in regard to a magistrate having no option but to impose a jail sentence following a second conviction for having liquor for sale illegally, and the other, which made the possession of liquor in living apartments connected with a store an offence in all circumstances. He said he considered the jail sentence proper for regular bootleggers, but too severe for a technical breach of the act.

Admits One Charge.
The only charge he admitted was that in one case (O. T. A.) he imposed a fine less than the minimum specified in the act. He fined one Martin \$100 when the lowest fine should have been \$200. The crown attorney was present at the time and he and the magistrate had both failed to note the error. The other judgments in his opinion had been proper and he gave the reasons he had for making the fine what it was. He said he had no other fine in all the cases were the lowest penalty imposed.

Must Go On, Says Raney.
Hon. W. E. Raney, when interviewed yesterday afternoon, said he could see no reason why the inquiry at Cayuga should not proceed. In view of the charges that had been made it was only fair that the inquiry should be completed.

NO SELECTIONS MADE OF U. S. AMBASSADORS

Washington, March 10.—So far as diplomatic appointments are concerned, it was stated authoritatively today in official circles that President Harding has made no final selections as yet of United States ambassadors to foreign capitals under his administration.

This task, along with numerous others of domestic and foreign policy, is now pressing, and the president has many names under consideration for the various posts that will be open immediately in Europe and elsewhere.

The nearest approach to an actual choice is understood to be Myron T. Herrick of Ohio for ambassador to France, a post from which he resigned early in the first Wilson administration.

EX-SERVICE MEN NOT OVERLOOKED

Reply Given South York
Member Respecting
Postoffice Jobs.

Ottawa, March 10.—(Special).—The rights of returned soldiers under the civil service act and the treatment they are receiving in the Toronto postoffice were the subjects of interpellation of the ministry by W. F. Maclean (South York) in the House of Commons this afternoon. Mr. Maclean asked:

"Were a number of single women appointed to the permanent staff in the Toronto postoffice when 55 returned soldiers with the necessary qualifications were overlooked? If so, why?"

To this Hon. C. J. Doherty, minister of justice and acting postmaster-general, replied:

"Ten single women, one of whom has since resigned, were selected for permanent appointment by the civil service commission. They had all passed the necessary civil service examination to qualify for permanent appointment and were the senior qualified temporary clerks."

"Fifty-five temporary clerks were taken on for the annual leave. Five of them were transferred to other departments afterwards kept on to fill permanent vacancies on the staff. Eleven of the remaining fifty were kept on temporarily to replace permanent clerks absent on account of illness, and 39 were let out, their services not being required. None of the 39 were permanent appointments."

"No returned soldiers who possess the necessary qualifications have been overlooked."

Mr. Maclean also asked: "Has the postoffice department taken advantage of the date of the passage of the act as recently amended? The question has been amended to meet this objection, and the answer by the government will be given on Monday next."

CREELMAN'S RESIGNATION OFFICIALLY ANNOUNCED

London, March 10.—(By Canadian Associated Press).—It is officially announced that F. C. Creelman, agent-general for Ontario, has resigned to accept a position as general manager of the Niagara Peninsula Fruit Growers' Association. He will sail for Canada at the beginning of April.

Hon. Manning Doherty, minister of agriculture for Ontario, stated today that the date of the resignation of Mr. Creelman's successor would be given out until his own return to Canada.
