Dwight, the Superintendent of the Western District, a gentleman who has had regard not so much for an immediate return for the work undertaken as the certain, steady expansion of business in a corresponding ratio with the increase of trade or population. Mr. Dwight's management extends over the most important section of the Company's territor.
