**DRUNKEN QUARTETTE**  
Four arrests for drunkenness were made by the police last evening.

**REPAIRING THE LUDLOW.**  
The ferry steamer Ludlow is now on Gregory's blocks receiving her annual overhauling.

**FOR BOSTON.**  
The steamer Governor Dingley sailed for Boston yesterday morning with about sixty passengers and a fairly large cargo.

**LITTLE DAMAGE DONE.**  
The North End fire department were called out yesterday afternoon for a slight fire which occurred in a shop at the corner of Camden and Simonds streets. Little damage was done.

**NATIVE BERRIES.**  
The second shipment of native strawberries of the season arrived from up river yesterday, and were selling at 50 cents per box. The berries came from Earle's wharf, on the Bellisle.

**HAD HAND HURT.**  
W. E. Fisher, 79 Bridge street, an employee of the Maritime Mail Works, had his hand cut yesterday morning while at work at a machine. The wound was dressed at the General Hospital, after which he went to his home.

**FREE SWIMMING.**  
There was an attendance of 185 boys at the Y. M. C. A. pond yesterday, being instructed to swim. A picture was taken of the party outside the building and another one of the boys in the tank. Tomorrow the boys will be given tests and awards made.

**WARNING ISSUED.**  
A warning has been received by firms in the city to be on their guard against \$100 counterfeit bills on the Federal Reserve Bank of Cleveland and the Federal Reserve Bank of New York. They are said to be printed on genuine paper and so well produced that they would take an expert to discover a fake.

**PROBATE COURT.**  
Argument was concluded yesterday afternoon in the Probate Court in the matter of the contested will of the late Charles Nevins. His Honor Judge McInerney said that there had been a complete change of position during the hearing of the case, but judgment would be announced as soon as possible.

**NEW STEEL BRIDGE.**  
Hon. P. J. Venet, Minister of Public Works, announced yesterday that a new steel bridge on a concrete base would be erected at Musquodchuic this year. The concrete foundation, he said, was expected to take three months to build, and tenders for the work would be called for inside of ten days.

**TO HOLD CONFERENCE.**  
Arrangements are being made for the holding of a joint meeting of the New Brunswick, Nova Scotia and Prince Edward Island Pharmaceutical Associations in Moncton on June 27, 28 and 29. It is expected that the matter of amalgamation of these associations into a Maritime Province association will be discussed and perhaps decided on. Several representatives from this city are expected to attend the meeting.

**WRITING EXAMINATIONS.**  
A class of about thirty are taking pharmaceutical examinations being held in the National History room yesterday and today. Yesterday the papers were on general subjects, materia medica and chemistry, and today's subjects will be pharmacy and dispensing. The examiners are: Dr. H. S. Bridges, general subjects; E. R. W. Ingraham, materia medica; E. A. MacKenzie, chemistry; G. B. Spencer, pharmacy; and G. Hadley Forbes, dispensing. Mr. Clinton Brown and George F. Coupe form the committee in charge of the examinations.

**ARRESTED AT BONNY RIVER.**  
John Jessop will appear before Magistrate Henderson this morning to answer a serious charge, he is alleged to have committed, of which a thirteen year old girl was the victim. Jessop, who was arrested by Marshall Goodill of St. George, at Bonny River, Tuesday, at the request of the local authorities, was brought back to the city yesterday in the custody of Detective Thompson.

## Expect Heavy Tourist Travel

Many Communications from Outside Points Looking for Hotel Reservations for July and August.

The approach of the warm summer season this year gives promise of an influx to the city in the way of tourist travel. The secretary of the Board of Trade, received a letter yesterday from a party in Concord, New Hampshire, enquiring for tourist literature, and a tour of the hotels brought out the fact that they expect a busy summer. One of the large hotels has received many communications from outside points, looking for reservations for July and August, and others are coming in daily.

A few motor cars bearing United States license tags have been their appearance on the city streets, although tourist travel has not yet become particularly heavy. The intense heat, which has permeated the New England States recently, will have a tendency to cause those who are fortunate enough to be able to take the time, to seek the cool climate of the provinces by the sea, and it will not be long before the influx will come east.

The new New Brunswick booklet, issued by the Tourist Association, is now being distributed at various points in the United States and Upper Canada, and this, setting forth, as it does the many and varied attractions which this province possesses for the tourist, innumerable and big game hunter, should bear fruit, and swell the numbers of those who will seek their recreation this season in this province.

## Scheme For Better Water Service

Preparations to Carry Pipe Line Through Fairville—Increase Property Value.

Commissioner Wigmore has a new scheme for bettering the water service to the people of Lancaster Heights, and he and Councilor John T. O'Brien are to take up the matter with Premier Foster at an early date. The Government had decided to lay a main from the Spruce Lake line to the Provincial Annex and carry it directly across from Manawagonish road to the Annex.

The new proposition is to carry the line through the Prefontaine-Bovard land, Fairville Plateau, Laurendie holdings and other undeveloped sections and thence down the Sand Cove road to the Annex. It is also hoped to have a portion of the Government land along the pipe line on Sand Cove road opened for building purposes. A strip 100 feet in width is suggested. The whole scheme would tend appreciably to increase the property value and would enable the securing of the 10 per cent. guarantee required by the city.

Commissioner Wigmore explained that the proposed new line, carrying the Spruce Lake main outside Fairville, beyond the area where the heavy draft on the water begins, would result in obtaining a considerable decrease in pressure and supply and would greatly benefit the higher levels in Lancaster, in that, instead of the people there being dependent on a return feed from the Provincial street line, they would get their supply direct.

The work would help out in taking care of the unemployment situation.

## Now Commanding British Squadron Heavy Brigade Not Coming Here

Major Norman P. McLeod Appointed in Place of Col. W. H. Harrison. Resigned.

Owing to the resignation of Lieut. Col. W. H. Harrison, D. S. O., as officer commanding the 3rd New Brunswick Heavy Brigade, several changes have been made necessary, and Capt. J. J. Harris, armament officer of Military Districts 8 and 9, has been in the city the past few days in this connection.

Major Norman P. McLeod, M. C., has been appointed as commanding officer of the 3rd New Brunswick Heavy Brigade. His position as O. C. of the 4th Siege Battery will be filled by Captain E. M. Slader, at present O. C. of the 15th Heavy Battery. Another Captain Slader's battery will be taken over by Captain D. V. White, of the 4th Siege Battery. Lieut. A. A. Dodge will become captain of the 4th Siege Battery.

Colonel Harrison said yesterday that he was resigning because his work of reorganizing the brigade was finished and he had served for twenty years. He had only stayed in the province for the purpose of reorganization.

Colonel Harrison joined the militia in 1899 as a lieutenant in the 3rd New Brunswick Regiment of the C. G. A. (now the 3rd N. B. Heavy Brigade), and has been connected with it up to the present. In 1914 he organized the Second Division Ammunition Column took it overseas and was in command of it throughout the war. While in France he was several times mentioned in despatches and was awarded the Distinguished Service Order.

On his return to St. John at the close of the war, Colonel Harrison was given command of the 3rd New Brunswick Heavy Brigade, C. G. A., and has completed his work of reorganizing it as the 3rd New Brunswick Heavy Brigade consisting of three batteries, the 4th and 5th Siege Batteries, and the 15th Heavy Battery. Last year Col. Harrison was awarded the Long Service Medal for more than ten years' service. He is the senior major in the 3rd New Brunswick Heavy Brigade.

Major Norman P. McLeod, who has been appointed to Colonel Harrison's post as officer commanding the 3rd New Brunswick Heavy Brigade, was a member of the 3rd Regiment C. G. A. before going overseas. His fighting career started in the South African war with the 1st Field Artillery in the same unit which Colonel A. T. Ogilvie, D. S. O., was an officer. In the last war he went overseas as a lieutenant with the 3rd New Brunswick Heavy Brigade, and was later promoted to captain and then to major.

Major McLeod was promoted to the rank of major in the 3rd New Brunswick Heavy Brigade, and was later promoted to the rank of lieutenant-colonel. He was awarded the Croix de Guerre and was promoted to captain. He was made adjutant of the 3rd Heavy Brigade and later made O. C. of the 15th Heavy Battery.

Captain D. V. White went overseas in 1914, and given command of a battery. He won the Military Cross while in France.

Lieutenant A. A. Dodge is another member of the 3rd Regiment. He went overseas with the Ammunition Column under Colonel Harrison as a quartermaster-sergeant, was promoted to sergeant-major, and later to lieutenant. He served for a year with a field battery and on his return here was made an officer of the 3rd N. B. Heavy Brigade. While in France he was given the "Meritorious Service Medal."

**MUST COMPLY WITH LAW.**  
Mayor McLellan yesterday issued a warning to the city's taxi drivers of the city that they must comply with the law requiring them to take out licenses and stated that those who did not do so might find themselves subject to full penalty of the law. He pointed out that truck owners who used their vehicles after hours and on holidays as taxis must take out a regular taxi license or take the consequences.

**SWIMMERS SWARM TO SCOWS.**  
Cold weather holds no fears for the city's swimming enthusiasts. If the attendance at the public swimming pools be any criterion, for large numbers of swimmers, both young and old, are in daily attendance there. A fee of \$1 is being charged for a season ticket for adults patronizing the pools, while the juniors are admitted free. The foot of Kennedy street has been closed as a public ash dump, and such material as is being used for a new sewer extension off that street in the direction of Marble Cove.

**WILL BE ORDAINED SUNDAY.**  
Three young St. John men, Harry McGuire, son of Thomas McGuire, Edward Howard, son of Mr. and Mrs. David Howard, and Joseph O'Hara, brother of Miss Margaret O'Hara, will be ordained by the Rev. J. J. Harris, at Mount St. Alphonsus, Esopus, N. Y., this coming Sunday.

Mr. Thomas McGuire, his daughter Miss Helen, and Miss Edward McGuire, of Halifax, Miss Margaret O'Hara, and Miss Catherine Coughlan, Mr. and Mrs. David Howard, and their four sons, have left to be present at the ceremony.

**TRY NEW WHARF SURFACE.**  
Amongst the improvements planned by the harbor department for their property on the West Side this summer, Commissioner Ballock stated yesterday, was a plastic asphalt covering for those wharves on which there was team tracks. Roadway wharf may be the first of these to receive the new covering.

The harbor department is planning a new floor and new stringers in No. 4 wharf, West St. John, and also repairing the ramp which runs from that wharf to the immigration shed. Repairs to the trestle and platform on the face of the wharf are also being carried out. The new floor on No. 5 wharf is about half completed and the work is held up awaiting deals.

Admiral Pakenham Expresses Regret That He Would Be Unable to Visit St. John.

St. John is not to have a visit from the British squadron which is touring the Atlantic ports of the United States and Canada, being returning to its home base, according to word received yesterday by R. R. Armstrong, president of the Navy League of New Brunswick, who yesterday received a letter from Admiral Pakenham, of H. M. S. Raleigh.

Admiral Pakenham, writing from Bar Harbor, Me., under date of June 12, thanked Mr. Armstrong for his kind invitation to visit St. John, as this city had a reputation which guaranteed a pleasant stay for all who had the good fortune to come here, and expressed his regret that he would be unable to come here during the present cruise.

Some time ago the itinerary of the squadron, which is composed of three vessels, was published, and the name of St. John, Canada's chief winter port, was not mentioned. Mr. Armstrong as president of the Navy League, took the matter up and wrote Admiral Pakenham extending an invitation to pay this port a visit, to which the above is a reply.

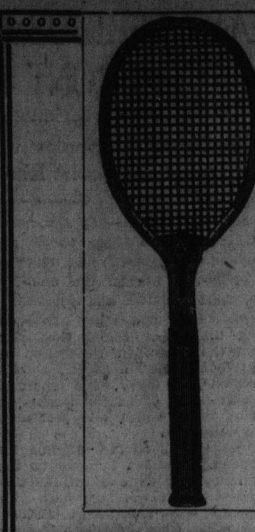

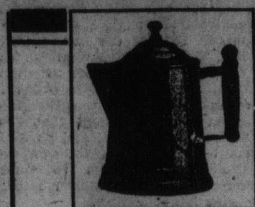

Porter Tuesday evening, it was stated that the amusement committee had not as yet had offered to them an attraction which, in their opinion, was good enough for the "head liner" of the fall fair, and the committee were thereupon given power to send a delegate to New York to secure the same, should it be found necessary.

President E. J. Terry was in the chair, and the reports of different committees were received, all showing progress. During the past month all the concessions, with the exception of the dining room, have been taken up. Acting on the recommendation of the art committee, the work of the local artists, Charles Ward and John C. Myles, and other local artists of note, will be shown, instead of the loan exhibits of former years. It was further reported that a review of the good repair in which the buildings and grounds were in, very little expense would be incurred in that respect this year.

## Obituary

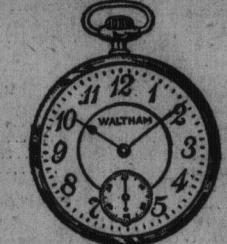
Otis E. Hoyt
