Tariff Impacts of Free Trade

U.S. tariffs on sporting equipment ranged from 1.5% to 7.8%. Under the Free Trade Agreement, items in this category become duty free in various stages. Some became duty free on January 1, 1989. Some tariffs are reduced in five equal stages to reach duty-free status by January 1, 1993, and the remainder in ten equal steps to reach duty free status by January 1, 1998.
