Hon. Ron Basford (Minister of Consumer and Corporate Affairs): 1. Yes; N.C.S. Foundation was incorporated by Letters Patent dated May 12, 1961.

#### NUCLEAR POWER STATION BIDS BY ATOMIC ENERGY OF CANADA LIMITED

#### Question No. 172-Mr. Broadbent:

- 1. For the years 1960, 1961, 1962, 1963, 1964, 1965, 1966, 1967, 1968 and 1969, what formal bids have been submitted by the Atomic Energy of Canada Limited to other countries for nuclear power stations?
- 2. In each case, what was the financial amount involved and was the bid successful?

Hon. J. J. Greene (Minister of Energy, Mines and Resources): Atomic Energy of Canada Limited advises as follows: 1. and 2. 1960-1967 inclusive, nil; 1968—Atomic Energy of Canada Limited assumed nuclear power marketing responsibility in July 1968. No formal bids were submitted during 1968. 1969—During 1969 a preliminary offer was made to Greece which was not taken up; this offer was valued at \$75 million to Canada. A formal bid has been submitted to Rumania. This bid is currently under negotiation.
