Mr. Trudeau: Mr. Speaker, if the Leader of the Opposition is anxious to have this particular subject discussed he could, of course, use one of the opposition days to do that.

Mr. Stanfield: The Prime Minister should read the rules again.

ALLEGED HIRING OF UNILINGUAL TRANSLATORS FROM FRANCE

ALLEGED INEFFECTIVENESS OF POLICIES IN QUEBEC— MEETING WITH PREMIER—DISCUSSION OF CRITICISMS WITH ATLANTIC PROVINCES' PREMIERS

Mr. James A. McGrath (St. John's East): Mr. Speaker, I wish to direct a question to the Minister of Regional Economic Expansion. In view of statements made by the Prime Minister of Quebec to the effect that government policies have been ineffective in that province in ending regional disparities, does the minister intend to meet with the Prime Minister of Quebec to discuss this very important matter?

**Mr. McGrath:** Does the minister intend to meet with or call the premiers of the four Atlantic provinces, as requested in the report of the Atlantic Development Council, to discuss criticisms aimed at his policies in the Atlantic provinces?

**Mr. Marchand (Langelier):** Mr. Speaker, I met with them last week and all of them were very happy with what we were doing in Nova Scotia, in New Brunswick, in P.E.I. and in Newfoundland.
