Motion proposed, that Mr. Speaker do now leave the Chair; Debate arising thereon; Debate adjourned, 115. Resumed and adjourned, 138, 140, 161. Special precedence given to Order for consideration of Resolutions, 182-184. Debate resumed and adjourned, 184. Debate resumed, 192. Amendment proposed by Mr. Cameron (Huron), for the appointment of a Select Committee of Inquiry, &c.; Debate arising thereon; adjourned, 193. Amendment negatived, 197-199. Amendments proposed by Messrs. Vail and Blake negatived, 205-207. Main motion agreed to. House went into Committee and adopted eleven Resolutions, 208-210. Special precedence given to Order for concurrence in Resolutions, 226. Resolutions reported and read the first time, 227-229. Motion for second reading; amendment proposed by Mr. Watson; negatived on a division, 229. Amendment proposed by Mr. Weldon; negatived, 230. Resolutions read a second time and agreed to, and Bill (No. 101) to amend the Act intituled: "An Act respecting the Canadian Pacific Railway," and for other purposes: presented, 232.
