SUGGESTED MEASURES TO ALLEVIATE UNEMPLOYMENT AND

PROPOSAL TO DEBATE CONSTRUCTION OF NORTHERN PIPELINE  
FOLLOWING RECEIPT OF REPORTS THEREON—MOTION UNDER  
S.O. 43

**Mr. John C. Crosbie (St. John's West):** Mr. Speaker, I, too, rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity. In view of the fact that the government of Canada will have to make a decision on a northern pipeline and on the issues considered by the Berger inquiry and by the National Energy Board, by consultants and by Dean Lysyk of the University of British Columbia, and in view of the paramount importance of the involvement of and consultation with the House of Commons before the government makes any final decision upon proposals for the construction of a northern pipeline, I move, seconded by the hon. member for Provencher (Mr. Epp):

That the government be instructed to initiate a full debate in this House concerning proposals for the construction of a northern pipeline once all of the relevant consultants, boards, commissions and committees have reported on the matters referred to them in connection therewith, and that no final decisions be taken in connection with such matters until after full debate so that the views of members of the House as to what action should be taken in the national interest may be known.
