During the first years of the existence of the Society its progress was slow and difficult, but by the close of the year 1883 we had more than one thousand members enrolled, and success was assured.

During the seven years from July, 1879, to July, 1886, we have paid 54 death claims, aggregating \$64,005.00. The smallest amount paid was \$206.00, Nov. 3d, 1880. The largest amount paid was \$3,500.00, May 13th, 1886. The average amount paid was \$1,185.00.

The average age of deceased members is 46 years. The aggregate amount of money received and expended during seven years is \$82,645.00. Of this amount \$64,005.00 has been paid to the heirs of deceased members, and \$18,640.00 expended in the organization and management of the Society.
