he shall be committed to the common gaol, there to remain until he shall consent to be so sworn or to affirm or answer; and if. guilty person, upon such examination, it shall appear that an offence has been committed against any provision of this Act, it shall be the duty of such Justice or other Functionary to issue his Warrant for the 5 arrest of the offender and search of his premises, and to convict him if found guilty.

XIX. It shall be lawful for any Justice of the Peace, Reeve, Police Magistrate, Recorder, Commissioner or Judge authorized to hear and determine offences against this Act, to summon 10 give evidence. any person who may be represented to him as a material witness in relation to any offence against this Act, and if such person shall refuse or neglect to attend, pursuant to such Summons, the Justice or other person authorized to try the offence, may issue his Warrant for the arrest of the person so summoned, 15 and such person shall be brought before the Justice or person issuing the Warrant, and if he shall refuse to be sworn o to affirm or to answer any question touching the matter under investigation, he may be committed to the common gaol, there to remain until he shall consent to be sworn or to affirm and 20 answer; and all the provisions of any Act or Acts for the protection of Justices of the Peace when acting, or to facilitate proceedings by or before them, in matters relating to summary conviction and orders, shall in so far as they may not be inconsistent with this Act, apply to every Functionary mentioned in 25 this Section or empowered to try offenders against this Act, and such Functionary shall be deemed a Justice of the Peace within the meaning of any such Act, whether he be or be not a Justice of the Peace for other purposes.

> XX. Every Justice of the Peace, or other Public Functionary 30 who shall neglect or refuse to perform any duty required of him by any Section of this Act, shall, upon conviction thereof, in any Court of competent jurisdiction, be adjudged guilty of a misdemeanor, and shall be punished by fine not exceeding One Hundred Pounds, and such conviction shall work a forfeiture of \$5 Office in all cases.
