Mercantile Summary.

JOHN W. BRAY commenced in the hardware business in Port Arthur in June, 1901. One year ago he made a statement showing a surplus of \$1,300 in his business. From the very beginning he has been found slow pay, however, and now he assigns.

Two Scotchmen, trading in fruits at Vancouver, under the style of Hood, Aldridge & Co., have assigned. This firm succeeded Bennet, Hood & Co. in July, 1900, claiming at the time to have an investment of between two and three thousand dollars. Their business experience was meagre, but they were ever hopeful and counted on assistance from time to time from relations "at Home." This did not always come, and as they were served with a writ for \$400 some time ago, they have now assigned.

A GENTLEMAN residing in Montreal, who had read our recent articles on the fuel question, tells us that he has derived great satisfaction from burning soft coal in a furnace made by the Robb Engineering Company, Limited, Amherst, N.S. We have made further enquiry respecting this "Robb heater," and find that it has been on the market for the past six years, and has proved a great acquisition to many people. It is radically different from the ordinary patterns of hot water heaters, and escapes the objections common to the older forms. It will successfully (and here is its strong virtue at the present time), burn all kinds of fuel, and is therefore suitable for any locality. It does not clog with soot when burning the soft coal found in Nova Scotia, British Columbia, and other parts of Canada. Several of these heaters are in use for heating large houses in country districts where wood is the principal or only fuel. Hard coal and coke have also been used with satisfaction.

FINANCES IN THE UNITED STATES.

Henry Clews & Co., New York, in their circular dated October 11th, 1902, say: Wall street is paying the penalties for excesses of the last twelve months. Forced liquidation upon a very extensive scale has been going on for several weeks, particularly in stocks which had been advanced by several well-known wealthy cliques, whose activities had frequently been a subject of wonder and Apparently these gentlemen criticism. had not sufficiently protected themselves against the fall monetary stringency. Call money was sharply withdrawn, and as time loans matured they could not be renewed upon the old terms or upon the old collateral. Bankers found good and more legitimate employment for their funds in the usual crop and trade demands, and resolutely set themselves in opposition to continued fostering of reckless speculation. At last New York banks found it to their common interest

to put a check upon the plunging operations which have recently characterized the transactions of certain cliques; and this they have done, none too soon, in a manner and with an efficiency that deserves the thanks of the entire financial and business community. New York bankers with their vast control of credit have a power of restraint upon speculative excesses which no other body of men possess; and their breadth of view apparently convinced them that their own interests are best conserved by unitedly acting for public welfare. Had it not been for the conservative attitude of the banks, stimulated of course by awkward monetary conditions and a sense of self-preservation, we should no doubt have run into a whirl of crazy speculation, which would have ended in premature panic and disaster. As it is, present liquidation will clear the financial atmosphere; and unpleasant conse-
