**Mr. John R. Matheson (Parliamentary Secretary to Prime Minister):** 1. Permission was requested for the tabling of the following two letters: (a) Letter of July 24th, 1964, from the Prime Minister to the premier of Saskatchewan concerning a proposed meeting of federal and Saskatchewan officials to discuss the developing and marketing of electrical energy from lignite coal. (b) Letter of September 16th, 1964, from F. A. Milligan, assistant secretary to the cabinet, to Dr. J. J. Moore in the office of the premier of Saskatchewan, concerning a proposed deferment of the meeting of officials.

ACCESS ROADS PROGRAM, CHAPLEAU  
COUNTY, QUE.

Question No. 1,092—**Mr. Laprise:**

1. Since the start of the joint program for the construction of access roads to resources, what projects have been undertaken and completed in Chapleau county?
2. What access roads to resources are being constructed at the present time and when will these projects be completed in each case?
3. Are there any projects under study at the present time and if so, what are they?

**Hon. Jean-Luc Pepin (Minister of Mines and Technical Surveys):** 1. (a) Amos-Matagami road, 118 miles—commencing at the town of Amos and travelling in a northerly direction to Matagami lake and the New Hosco mine. 54 miles completed. (b) Lac Waconichi-Lac Albanel road, 97 miles—commencing at the southerly tip of Lac Waconichi to a point a few miles north of the 51st parallel on the eastern shore of Lac Albanel. 88 miles completed. (c) Chapais-Desmaraisville road, 30 miles—commencing at a point 14.6 miles east of Desmaraisville to a point approximately 27 miles west of Chapais. 30 miles completed.

2. Amos-Matagami road and Lac Waconichi-Lac Albanel road are being constructed at the present time. Completion date determined by provincial schedule. Roads to resources agreement with province expires March 31, 1966.

3. There are no projects under study at the present time.
