PRIOR DISCUSSIONS RESPECTING APPLICA-TION OF U.S. MONETARY POLICY

On the orders of the day:

Mr. T. C. Douglas (Burnaby-Coquitlam): May I direct a question to the right hon. Prime Minister. At a press conference last week United States Commerce Secretary Connor said that before imposing the United States guide lines the reaction of the Canadian government had been sought at a high level. I should like to ask the Prime Minister if there have been any discussions with him or with any of his ministers regarding this question, and if so, which ministers were consulted.

Right Hon. L. B. Pearson (Prime Minister): Yes, Mr. Speaker. The Minister of Finance has already indicated that discussions between the two countries took place last autumn, not only in respect of the guide lines but on other aspects of financial policy as well.

Mr. Douglas: A supplementary question, Mr. Speaker. May I ask the Prime Minister if the United States Secretary of Commerce is correct in indicating that at that time there was no indication of any unfavourable reaction from the Canadian Government?

Mr. Pearson: I think the Minister of Finance who took part in these discussions, will deal with that question.

Hon. Mitchell Sharp (Minister of Finance): Mr. Speaker, I gave a full account of the discussions that took place between the Canadian government and the United States government at both the ministerial-secretarial level and at the official level. We made it quite plain to the United States government that we did not think that the guide lines on direct investment were in the interests of either Canada or the United States.
