Could he advise the house in respect of the meeting regarding the area development program held this morning with representatives from the Atlantic region?

Hon. C. M. Drury (Minister of Industry): Yes, Mr. Speaker. I met this morning with the minister of economic development of the province of New Brunswick and the mayor of Saint John with regard to the possible designation of Saint John and other metropolitan areas in the maritimes under the designated area program. We had a useful discussion and I hope that we resolved what has been a misunderstanding arising out of a question and answer which appeared in Hansard. The minister and the mayor both recognized that this program, which has resulted in some \$680 million of new investment in the Atlantic provinces and the creation of some 17,000 jobs, has been extremely useful. I pointed out to them that this program, which is in the nature of a crash program relating to unemployment, is due to expire in 1971 and that if and when in his new tenure the minister of economic development of New Brunswick should bring forward proposals for making this program more relevant to the economic development plan in the Atlantic provinces I would be glad to discuss them with him.

Mr. Thomas M. Bell (Saint John-Albert): Mr. Speaker, would the minister be willing to attend the meeting of the Atlantic premiers which has already been called for March 21 in Fredericton to deal with this matter, put forward the thoughts he has in mind today and attempt to settle the matter once and for all?
