Hon. Ron Basford (Minister of State for Urban Affairs): Mr. Speaker, I should like to give a very brief explanation of our reason for moving this amendment and to urge the support of members opposite to this amendment. This section was amended in committee on motion of the hon. member for Oshawa-Whitby (Mr. Broadbent). I appreciate his motives and his intention in moving it. He believed that the forgiveness provision of the repair and rehabilitation sections should be limited to amounts set by regulation of the Governor in Council in relation to the income of the recipient. The previous bill, as introduced in the committee, set the amount of forgiveness at \$2,000. The amendment of the hon. member for Oshawa-Whitby, which was approved by the committee, had I think an effect which may not have been foreseen.
