Miss MacDonald (Kingston and the Islands): A further supplementary. While everybody might have full regard for Mr. Justice Berger they do not have the same confidence in the government not to interfere with his inquiry.

INFLATION—NECESSITY OF PARTICIPATION OF MAJOR UNION IN CONSENSUS PROGRAM OF RESTRAINT—POSSIBILITY OF PROPOSALS ON EMPLOYMENT GROWTH AND JOB SECURITY

Mr. John A. Fraser (Vancouver South): Mr. Speaker, a question for the Acting Minister of Finance. Since the government recognizes that no one group will co-operate unless it knows others will be exercising similar restraint, is it the position of the government that the participation of the major unions such as the United Steel Workers would be a pre-condition to the consensus program?

Hon. C. M. Drury (Acting Minister of Finance): Mr. Speaker, this is the kind of issue that is currently being discussed. To lay down, in the form of ultimata, what people must do or must not do would not help the process of trying to find a consensus.

Mr. Fraser: A supplementary question, Mr. Speaker. Can the minister tell the House whether the government has presented any policy with regard to employment growth and job security for the consensus period and, if so, have any proposals been prepared on this matter to be part of a consensus package?

Mr. Drury: Mr. Speaker, obviously there are a number of possible scenarios which are not being prepared, projected or discussed in detail but rather there is a process of seeking consensus on general principles such as was enunciated by the Minister of Finance to the first ministers' conference and subsequently communicated to the House.

Mr. Gordon Ritchie (Dauphin): Mr. Speaker, I also have a question for the Acting Minister of Finance regarding the consensus. Hon. C. M. Drury (Acting Minister of Finance): Mr. Speaker, in respect of specific questions, we are working on these to find answers as quickly as possible.

REQUEST MINISTER CONTINUE NEGOTIATIONS WITH POSTAL WORKERS ON ISSUES OF CASUAL WORKERS AND AUTOMATION
