INTERDEPARTMENTAL COMMITTEE ON FORMS STANDARDIZATION

Question No. 3,883-Mr. Beatty:

- 1. What is the nature of each and every form sent to businesses on a routine basis by the government including (a) the department or agency sending the form (b) the type of business to which it is sent (c) the type of information sought (d) the uses to be made of the information gathered (e) the regularity with which each form is sent to a single business (f) the number of businesses to which each form is sent?
- 2. What measures, if any, are being taken by the government to reduce the amount of paperwork businesses are required to complete for the government?

Hon. Jean-Pierre Goyer (Minister of Supply and Services): The Interdepartmental Committee on Forms Standardization reviews and standardizes governmental forms. This function is carried out for the purpose of creating greater economies of scale in the printing area. The Committee would not normally consider forms sent to businesses and has neither the manpower, the financial resources nor the requisite authority to solicit government departments to determine the nature of forms sent to businesses.

ANNUAL INCREASES OF ASSETS OF EACH CHARTERED BANK

Question No. 3,888—Mr. Lambert (Bellechasse):

- 1. Between 1967 and 1974, what were the progressive annual increases of the assets of each chartered bank?
 - 2. In each case, what was the origin of such increases?

Mr. Jacques-L. Trudel (Parliamentary Secretary to Minister of Finance): 1 and 2. The assets and liabilities of each chartered bank, broken down by categories in accordance with Schedule M of the Bank Act, are published monthly in Part I of the Canada Gazette, including the period 1967 to 1974.

CANADA-USSR JOINT FISHERIES CONSULTATIVE COMMISSION Question No. 3,902—Mr. Marshall:

- 1. Has the Canada-USSR Joint Fisheries Consultative Commission been established and, if so, who are the two members appointed by the government?
- 2. To the knowledge of the government, has the USSR appointed a fishery official to provide statistical information with regard to fishing operations in the North West Atlantic and, if so, what are his terms of reference?
- Hon. Allan J. MacEachen (Secretary of State for External Affairs): 1. The Agreement between Canada and USSR concluded December 22, 1975 provided for the establishment of a Joint Fisheries Consultative Commission to be composed of two Commissioners from each side. Both Governments are in the process of determining appropriate Commissioners to be appointed in the near future.
- 2. The same Agreement also provided for the appointment of a Soviet fisheries official in Halifax. This official has not yet been appointed by the Soviet Government.
