tion. We regret that the resolution is not one that apparently finds favour with the government in the sense that it is going to take any action to express abhorrence or to impose further sanctions that might be effective in encouraging the Polish government to re-establish civil liberties in that country.

Mr. Laverne Lewycky (Dauphin): Madam Speaker, the New Democratic Party welcomes this opportunity to support this very positive motion. I think it indicates that our Parliament is concerned. We want to demonstrate this concern.

We are grateful that all three parties have supported this motion. I think we do have a moral responsibility. There are many Canadians who have friends and relatives in Poland, and they are legitimately concerned. Therefore, for our part we want to express our wholehearted support for this motion.

Madam Speaker: Is it the pleasure of the House to adopt the said motion?

Some Hon. Members: Agreed.
