(b) by striking out line 23 at page 18 and substituting the following therefor: "pletes three months of continuous".

(c) by striking out lines 28 to 42 at page 18 and substituting the following therefor:

"sion plan, the day on which three months have elapsed since the employee was first employed with a participating employer."

That Bill C-90, be amended by deleting Clause 15.

That Bill C-90 be amended in Clause 25 by striking out lines 5 to 44 at page 30, lines 1 to 50 at page 31 and lines 1 to 35 at page 32 and substituting the following therefor:
