CABINET ACCEPTANCE OF TELESAT MERGER AND REJECTION OF CRTC DECISION—MOTION UNDER S.O. 43

SUGGESTED IMPLEMENTATION OF HALL REPORT TO CREATE RAILWAY-RELATED JOBS-MOTION UNDER S.O. 43

REQUEST FOR STATEMENT ON NEW MARKETING STRATEGIES— MOTION UNDER S.O. 43

Mr. Don Mazankowski (Vegreville): Mr. Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity.

Having regard to recent predictions advanced by the Economic Council of Canada of a gloomy future for prairie grain farmers because of rising costs, depressed prices and a poor export potential, and given the fact that senior marketing analysts have predicted that Canada's future grain exports will fall by more than 20 per cent by the mid-1980s, and further given the fact that outstanding farm debt has doubled in the last six years from \$4.3 to \$8.5 billion, I move, seconded by the hon. member for Elgin (Mr. Wise):

That the Minister of Agriculture and the Minister in charge of the Canadian Wheat Board make a statement on motions at the earliest possible date outlining to the farmers and the people of Canada what new initiatives and marketing strategies are being proposed by the Canadian Wheat Board and the government of Canada to improve our export position, and further indicate what export targets and income prospects may be attainable into the 1980s in order that the producers may plan their futures in a more orderly manner.
