COUNCIL ADOPTS NEW METHOD OF GOVERNMENT

City Fathers Pass Commission Bylaw by Ten Votes to One.

LENGTHY DISCUSSION

Heated Controversy Staged Regarding Proposed New Garbage Scheme.

What the council did:
Ordered specifications for tenders for the garbage contract prepared by the city solicitor.
Decided that the city engineer's department should tender for the collection of garbage.
Referred back to No. 2 committee the proposed settlement of the William street sewer dispute.
Approved of the cut in cost of Dundas street east sewer from 73c to 50c per foot.
Decided to withdraw the appeal against the court of revision cuts in the Pipe Line road frontage charges for paving.
Discussed Alderman Ashplant's motion instructing officials to levy school tax equitably. Mayor Wilson ruling that motion was new and must have notice, blocking a vote.
Approved of the commission government bylaw.
Approved of street cleaning, sweeping, oiling and garbage collection charges for 1921, to be collected with 1922 taxes.
Instructed the solicitor to provide an amendment to the license bylaw, making it an offense for a juvenile to enter a poolroom.
Approved of the tender of Orth's, Limited, for firemen's forms.
Passed 168 bylaws, covering local improvements, paving, walks, curbs and gutters and sewers undertaken in 1921.

The city council on Monday night staged its longest session in some time, running within ten minutes of 11 o'clock, the official time for adjournment.
Long drawn-out fights over the commission government bylaw, the annex tax resolution and the garbage specifications being the main causes of the prolonged gathering.
It was a lively meeting, conducted for the most part in the best of spirit, though on a couple of occasions, Alderman H. B. Ashplant and Mayor Wilson got near the personal point.
Alderman Ashplant staged what might be termed a lone battle against the commission government bylaw, putting up the only fight that has yet been made against its adoption, although it has been approved by all the boards interested, with the exception of the Board of Education.
The alderman in attacking the measure went at it without gloves and almost exhausted a replenished store of sarcasm and adjectives in his effort to ridicule it.
Mayor Wilson's come-back in defence was quite pointed and successful, the bylaw carrying ten to one.

WHEAT PRICE BOOSTS COST OF BREAD

Ontario Conservative Delegates Balk In Caucus At Leadership of Meighen

FINISH FIRST DRAFT OF IRISH CONSTITUTION

Provides For Inclusion of N. E. Ulster, Giving Them County Legislatures.

WARNS DE VALERA
Freeman's Journal Places Responsibility of Incipient Turmoil.

Dublin, March 7.—The first draft of the Irish constitution was completed last night by a committee, of which Darrell Figgis is acting chairman. The draft will be submitted to the provisional government today for any changes that are deemed necessary. The constitution does not bind its people forever to the Irish Free State and contains nothing forbidding them from continuing a struggle for complete independence, according to reliable sources reaching the Associated Press.

Include Ulster.
The inclusion of Northern Ulster within the free state is provided for. The six counties would retain the powers they now possess, having their own legislature, functioning similarly to the legislatures of the Canadian provinces or the states in the United States with certain restrictions. Thus any act passed by the Ulster Legislature, if contested, would eventually come before the supreme court for all Ireland on the question of its consonance with the constitution.

Reports that Republican rebels have given free state forces 48 hours notice to surrender. Limerick police barracks today intensified the situation in Limerick and caused genuine anxiety to free states.
These reports were not substantiated, but it was agreed that free states would stubbornly resist possession and in event of an attack the barracks would be vigorously defended. No breach of peace, however, had been reported early today. Lack of authentic news intensified the seriousness of the real situation.

Issues Warning.
Freeman's Journal, under the headline, "A Dangerous Game," declared: "Attempts are being made to carry on political propaganda and develop a malignant spirit in certain sections of Ireland." The newspaper further declared: "Some adherents of document No. 2 have made up their minds that they cannot prevent by argument, establishment of the Irish Free State, and it looks as if they were about to try to see what can be done by turmoil. Incidents at Clonmel and Limerick already have shown how far the mutineers are prepared to go, but the Irish people will never submit to such acts of terrorism. Responsibility clearly rests on Eamon de Valera if he allows men under the protection of his name and influence to turn an appeal to honest judgment of the Irish democracy into a fratricidal conflict."

Ulster Party Quits Commons in Anger

LONDON, March 6.—(By Associated Press.)—All the Ulster members present walked out of the House of Commons tonight when during a discussion in the committee stage on the Irish Free State bill closure was adopted on section one of clause one, which is the operative provision of the bill as it declares the treaty shall have the force of law.
The closure vote was 182 to 31.
The closure, which cuts out fourteen proposed amendments, was vehemently resisted after it had been carried. The first sub-section was added to the bill by a vote of 183 to 30, after which there was a series of strong protests from the Ulstermen and the "die-hards" against application of closure.
Capt. Charles Curtis Craig, Unionist member for South Antrim, declared: "I am not a member of the Ulster Unionist Council, but I am a member of the House of Commons."

WRECKS G. T. R. TRAIN NEAR PARIS

The main line of the Grand Trunk was tied up for several hours early Tuesday morning as the result of a wreck two and a half miles west of Paris Junction.
A broken truck on a freight car caused two cars to leave the tracks at 45 a.m., tearing up the line for some distance.
The train was pulled by Engine 684, in charge of Engineer Owen Sarnia, and Conductor J. T. Smith, also of Sarnia.
Passenger trains were delayed over two hours, while train No. 75 from Toronto carrying Toronto morning papers was derailed via Stratford, arriving in London almost three hours late.

Britain Abandons Airship Fleet Plan

LONDON, March 7.—In consequence of India, South Africa and New Zealand having refused the imperial government's invitation for co-operative backing in the projected Imperial Air Service, the government has abandoned the intention of keeping up the airship fleet provisionally until June, and is now handing over the material, lock, stock and barrel, to the disposals board.

ASK INJUNCTION AGAINST CUT

Street Railway Men Send Second Appeal Against Wage Decrease to Board.

CLOUDED UP FACTS

President Colbert Admits Misunderstanding Due to Lack of Clearness in Presentment.

Dissatisfied with the decision of the Ontario Railway and Municipal Board, which has refused to take any action against the London Street Railway Company, the employees of the latter corporation, through their union officers, petitioned once again Tuesday morning to the former body asking that an injunction be granted restraining the company from effecting a wage reduction of three cents an hour.
John Colbert, president of the local street railwaymen's union, explained that the members of the latter organization were convinced that there exists a misunderstanding between the railway board and the men.

"We have petitioned the board again today," explained the president, "there appears to have been some misunderstanding between the board and ourselves. We have now prepared the problem again and have made the point that perhaps we did not place the facts of the question before the board in as clear a manner as we might have."
"This has been remedied, however, today, and we have dispatched our second appeal for action on the part of the board. In the meanwhile we will do nothing further until we receive a reply. Incidentally we are not a particle discouraged. The company has in our opinion violated the statutes and there must be some court in the land where we can seek and obtain redress."

Late Monday afternoon officials of the union were notified from Toronto that the provincial board had rejected their offer and no time was lost before the executive entered into special session and prepared a second appeal.

REV. ADELARDE DELORME REMANDED UNTIL MARCH 14

Request For Adjournment of Hearing Is Allowed by Montreal Court.

Montreal, March 7.—Rev. Adelarde Delorme, charged with the murder of his young half-brother, Raoul, appeared in the enquete court this morning and was remanded until March 14.
The request for the adjournment of the case for the attorney general's department indicated that the crown was ready to proceed but made no objection to the postponement.
Rev. Father Delorme was brought into the city from Bordeaux jail, where he has been housed since his arrest in the car of the high court stable. He wore non-clerical clothes. A large crowd was on hand to witness the transfer of the priest from the high constables' car to the court house, but it was not allowed in the enquete court.
EARTHQUAKE HEROINE DIES.
Vancouver, B. C., March 7.—Mary Helen Lawrence, proprietress of the Little Brown Inn in Vancouver, is dead of tetanus. She will be buried in Niagara Falls, Ont., her native town.
Miss Lawrence was decorated by King Emmanuel for her work in the Messina earthquake. She was a prominent member of the Independent Order of Daughters of the Empire and the Women's Canadian Club.

BLAME FORMER PREMIER FOR LOSING QUEBEC

Chief Opposition From Province Was Introduced by Toronto Delegates.

DISCUSS PARTY NAME

Large Number of Ontario Political Leaders Favor Immediate Convention.

BULLETIN.
Ottawa, March 7.—Members of the National Liberal and Conservative party, in caucus today, decided to return to the old name of Liberal-Conservative.

Ottawa, March 7.—Former Premier Arthur Meighen had no competition whatsoever yesterday in the matter of retaining the leadership of his party, which he has held since the retirement of Sir Robert Borden in July of 1920.

While there were sharp differences of opinion on the question, there was no other contestant, and the caucus which continues today had no choice but to unanimously reaffirm him as leader.

It is understood, however, that the approval is temporary in character, and that the whole matter will again be threshed out at a national convention to be held later.

Ontario Opposition Unexpected.
As has been said there were sharp differences of opinion at yesterday's conference, the clash being principally between the Quebec and Ontario delegates.

Under Mr. Meighen's leadership it was charged not a single Conservative candidate in Quebec secured election, and among the defeated were four ministers, Messrs. Ballantyne, Bell, Fawcett and Monty, and three senators, Foster, Beaudin and Webster.

It might have been expected that the opposition to Mr. Meighen's leadership would have emanated from this group, but the contrary was the case.

The chief opposition came from Ontario and from Toronto. In particular, Quebec delegates stood for Mr. Meighen unqualifiedly, but certain Ontario members frankly declared that no headway could be made under Mr. Meighen's leadership.
On the question of changing the name of the party from National Liberal and Conservative to the old historic appellation of Liberal-Conservative, there was also difference of opinion. Old Liberals such as Guthrie, Ballantyne, Tolmie, Calder and others holding by the long and hybrid name, while old Conservatives urged the change. The matter has not been decided.

There was a considerable body of opinion, particularly from Ontario, in favor of holding a national convention immediately. By the majority, however, it was felt better to wait and see how the coming session panned out.

The question of whether the Meighen or Crevier forces will constitute the official opposition is one on which there is divergence of opinions among both groups. It is a question which has not yet been decided, but general opinion is that the former party will assume the role.

RUMORS MEMBERS VIOLATED O. T. A.

Toronto Alderman Introduces Resolution Asking for Investigation of Ontario Legislature.

IRREGULAR CONDUCT?

Some Members of All Parties On Closing Night Last Session, Rumor Charges Believed Unseemly.

Toronto, March 7.—That a public investigation under the public inquiries act should be held to determine upon whom the responsibility should rest to prosecute violations of the Ontario temperance act, occurring in the parliament buildings or other public offices, was the demand of a resolution of which notice was given at the Toronto city council at an early hour this morning by Ald. John Cowan.

The resolution asked further that it be ascertained "whether the Toronto police force had any knowledge of the said cross veins of the Ontario temperance act or were in any way responsible for allowing the same to be carried out."

The resolution in question was made by Ald. Cowan to rumors of unseemly and irregular conduct on the part of some members of the legislature during the last night of the last session, in connection with the names of members of different parties government included, are implicated.

The resolution of Ald. Cowan was hotly criticised by some of the other members of the council, and described as "despicable" by Ald. Birdsall. However, the city clerk declared notice of the motion in order. The mayor allowed it to go into the records, and it will go before the board of control for further action.

BREAK GLASS AND STEAL JEWELRY FROM WRAY'S

London Merchant Loses \$520 Worth of Valuables During Night.

A diamond pendant, watches, stickpins, necklaces, etc., to the value of \$520, were secured by a thief, or thieves, when a store weighing over 100 pounds, was crashed through a window of Wray Jewellery, Limited, 234 Dundas street, some time between 5 and 6 o'clock Tuesday morning.

A policeman on the beat discovered the robbery, and Mr. Wray was immediately informed. The police had nothing to report on the matter late Tuesday afternoon.

This is the third time that Mr. Wray's premises have been visited by thieves in the past three years.

Two years ago the store was entered from the rear and jewelry stolen valued at \$3,500.

Three years ago a front window was broken with a brick and the culprits escaped with goods valued at \$1,100.

"They certainly seem to know which store keeps the good stock," said Mr. Wray, in discussing his loss.

"Part of the goods taken Tuesday morning were covered by insurance, and the window pane, which is just by the entrance, is fully covered by insurance. Two years ago when I lost over \$3,500, I did not have so much insurance."

"I have a full tally of everything taken and can identify anything that was in the window."

FAIL TO CIRCULATE MINERS' BALLOTS
Calgary, Alta., March 7.—Referendum ballots in district No. 18, United Mine Workers of America, embracing mines employing about 9,000 miners in Southern Alberta and British Columbia, have not been circulated by the international union, it was announced yesterday by E. G. Williamson, president of District No. 18, as the officials at Indianapolis did not comprehend the situation in Western Canada.

LAWYERS STAGE WORDY BATTLE IN BEER CASE

Magistrate Reserves Judgment On Hornick and Connor, Drivers of Truck.

IMPART INFORMATION

Counsel Explains Bootleggers Now Termed "International Traders."

London police court followers received much interesting information as to the workings of the Ontario temperance act so far as beer for export along the borders of the Detroit River is concerned, when the cases of Ed Hornick and Oliver Connor were called.

The young men were charged with having liquor in a place other than a private dwelling.
Judgment was reserved by Deputy Police Magistrate P. H. Bartlett.

The case drew three legal stars to the court, Mr. J. H. Jeffrey, K.C., of Quebec, appearing for the crown, and James Haverson, K.C., of Toronto, and W. H. Furlong, of Windsor, for the Kuntz Brewing Co. of Waterloo. Mr. Jeffrey and Mr. Haverson have met before in the legal arena and the court room was treated to "snappy" repartee.

The prisoners pleaded not guilty to the charge and Mr. Jeffrey called Sergeant Wm. Middaugh to the witness box.

Seized 140 Cases.
Sergeant Middaugh told of seizing 140 cases of beer, on a truck on Clarence street, south of Dundas street, on the afternoon of February 24. Hornick and Connor were the drivers. Each case contained 24 bottles. Hornick showed witness what he called clearance papers and told him there was any trouble to call up a man in Petite Cote.

Mr. Jeffrey—"I might explain your worship, the word is not petticoats. It is a place that is frequented by gentlemen who used to be called 'bootleggers,' but who are now termed 'international traders'."

Sergeant Middaugh stated that he detained the truck and drivers because it looked like an illegal shipment to him.

The cartons had labels pasted on them with addresses of men in Detroit. One read: Wm. J. Harding, Detroit, Mich.

"I would say, rather a loose and vague address," commented Mr. Jeffrey.

"Same name as the president of the United States, but the beer was not for him," declared Mr. Haverson.

Delivering New Truck.
Sergeant Middaugh stated that he had seen just east of the city limits. Hornick had told him he was delivering a new truck to Brantford. It had been made in Walkerville.

Cross-examined by Mr. Haverson, witness admitted that he did not know where the truck was going at where it had come from, except that Hornick had told him. There were no street addresses on the shipments. Hornick had stated that he was getting 75 cents a case for drawing beer to Petite Cote.

"Which is Mr. Hornick?" asked Mr. Haverson.

"What, don't you know your own client?" asked Mr. Jeffrey in shocked tones.

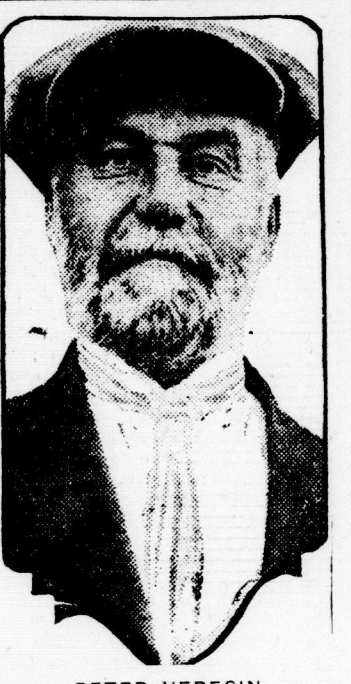
"Mr. Hornick told me that he had taken a load down a few days previously and that it was transferred to two waiting trucks. That was all he had to do with it."

Had Office in Windsor.
Constable Gavin Monahan, who also stopped the truck, stated that Hornick had said that he was carrying the beer for a Mr. Jeffrey, who had an office in Windsor.

Mr. Haverson went into detail on the cross-examination of Monahan regarding the custom papers, which, Mr. Jeffrey claimed, had no bearing on the case.

"You are always so instructive I hate to stop you," murmured the crown counsel.
Herbert F. Kuntz, one of the proprietors of the Kuntz brewery, Waterloo, was the first witness called for the defence. He was examined by W. H. Furlong.
Going to Detroit.
Mr. Kuntz stated that all the beer on the seized truck was going to Detroit on orders that had been received.
"How do you know the orders were from Detroit?" questioned Mr. Furlong.
"Because they were mailed from Detroit," was the reply.
Mr. Kuntz then stated the procedure on orders received from Detroit. E. W. Jeffrey was now called. Kuntz agent in Windsor, and on receipt of orders, he phoned the agent, who arranged to send trucks to Waterloo for the beer.
"We make out the export papers, six or seven copies," stated witness.
"We give the driver five, and he turns to Page 11, Column 4."

Heads Doukhobors

WINNIPEG, Man., March 7.—Again expressing hope that he will escape lynching at the hands of the women of Canada for his theoretical advocacy of massacre of the Doukhobor children and aged, and pledging his influence against the throwing of children into the Columbia River, Peter Veregin, president of the Christian Community of Universal Brotherhood, the Doukhobor organization in Canada, today renewed his demand for a commission of inquiry, and that the province reimburse the community for the roads it built, including a \$20,000 bridge, which was the community's invested capital, and also that a loan of \$50,000 be provided for irrigation.

WILL SUE CHAIR FIRM FOR \$3,000

Ratepayers of Strathroy Want Amount Claimed From Chair Company.

FOLLOWS COUNCIL'S MOVE

Mayor Bateman Declares People of Town Are Weary of Delay.

Special To London Advertiser.
Strathroy, March 7.—Ratepayers of Strathroy will move at once through the courts to secure from the Middlesex Chair Company the sum of \$3,000 and interest due, it is claimed, since 1915, Mayor Dr. F. A. Bateman announced here Tuesday morning. This follows the action of the council, who in general session last night accepted the company's offer that the money in question be paid in three one-thousand-dollar annual installments, without interest, commencing January 15, 1923.

"This question has been debated long enough," declared Mayor Bateman. "The taxpayers have proved beyond dispute that they want immediate satisfaction from the furniture company. Certain of them were merely awaiting the action of the council last night before they attempted drastic action through the courts. Now they will move without delay."

"We are not entirely satisfied with the result of last night's session. Deputy Reeve Pike tried to impress upon the councilors that it was their duty to at least ask the company for payment. He met with failure, however."

Councillor Laing also expressed himself this morning as being displeased with the action of his colleagues.

Favors Court Action.
"One important feature of this problem is," he pointed out, "that prior to the last election practically every member of the council either from the platform or during canvass promised that they would exert every effort to have this money collected."

Discussing the question briefly, Deputy Reeve Pike desired to draw attention to the fact that "three members of the council were employees of shareholders of the Middlesex Chair Company." He expressed pleasure, however, that it was now definitely decided that the matter should go to the courts for a clear-cut decision one way or the other.

SHOWS INCREASED PRODUCTION
London, March 7.—It is officially stated, says Reuters Sydney correspondent, that New South Wales primary production last year, including those of pastoral pursuits, dairying, agriculture and mining, amounted to \$23,000,000. There are nearly 4,000 acres under wheat at present and 1,000,000 other crops, this being the largest acreage of crops planted since the record year of 1915-16. The present year has also seen an influx of 800 additional growers of wheat.

LONDON BAKERS INCREASE LOAF TO 10 CENTS

Advance Believed To Be Surprise to Majority of Consumers.

FLOUR \$1.89 BARREL

One Firm in City Continues To Sell At Its Former Price.

Londoners whose appetites are stimulated three times daily by an extra slice of bread must bear the brunt of the blow which follows a boost of one cent on the price of each loaf.

Announcement of this increase in price was made today, the bakers responsible for it attributing the cause to fluctuations in the wheat market. The increase comes as a surprise to consumers in view of the fact that wheat was recently quoted at a dollar per bushel, with indications of a steady drop in prices. At that time the 24-ounce loaf was reduced to retail at nine cents in London, with citizens of Windsor, St. Thomas, Galt and other towns in the district remaining on the ten-cent list.

In contrast to the former price, wheat is now on the market at \$1.42 per bushel. According to figures made available by F. E. Parnell of the Parnell Baking Company, there are 4 1/2 bushels of wheat to every barrel of flour, and the jump in the market increases flour \$1.89 per barrel.

Advanced to 10 Cents.
Approximately 180 loaves of bread of 24-ounce weight can be produced from a barrel of flour, and the advance of one cent, as announced yesterday, means no further allowance for profit by the baker. In conjunction with the local increase it is predicted in bakery circles here that Western Ontario centres, in which bread is now sold at 10 cents per 24-ounce loaf, will experience a similar increase with bread sold to the people at 11 cents.

The increase in price is general throughout the city. W. Thompson, manager of the Neal Baking Company, confirmed the statement made by Mr. Parnell, that it was impossible to continue the sale of the 24-ounce loaf at 9 cents, and that the increase had been affected some days ago in several other towns.

B. F. Brighton made a similar statement and asserted that it was impossible to obtain flour when flour was low, in order to maintain a low price in face of market fluctuations.

Sells At Old Price.
The Nut Krust bakery is advancing its price one cent in keeping with other bakeries.

One firm, the Ruddy Baking Company, announced that it was continuing the sale of the standard loaf at 8 cents in spite of increased prices of wheat and anticipated no advance.

SEEKS PROVINCIAL AID.
Montreal, March 7.—Decision to ask authorization of the Quebec Legislature to spend \$200,000 in rebuilding the province of Quebec, and for the period of two years, and the expenditure of \$25,000 for clearing up the debris in the burned structure, and for the purchase of office equipment, were matters disposed of at the meeting of the city council, held in the recorder's court in the annex building yesterday. As the emergency meeting had been called irregularly, it was a decision to have the legislature legalize the decision.

The Weather

FORECASTS.
Today—Showery; strong northwest winds and turning colder tonight.

The disturbance west of Lake Michigan yesterday is now centered just south of James Bay, with somewhat diminished intensity. A development in the southern end of the trough formed by the disturbance now promises to be the more important area.
