Important Notice

According to the postal law now in
force, publishers can hold for fraud
any one who takes a paper from the
Post Office and refuses payment, and
the man who allows subscriptions to
remain unpaid and their orders a
postmaster to send notification of
discontinuance to the publishers,
lays himself liable to arrest and fine.
Postmasters are also liable under the
law for the cost of papers delivered
to other persons after the death or
removal from their office district of
the persons to whom the paper was
first addressed.

A name very prominent among
the opponents of Home Rule for Ire-
land is that of Sir Edward Carson.
It is he who has most urged upon
Ulster armed resistance to the Home
Rule measure. And yet when charges
were formulated against Sir Rufus
Isaacs, Mr. Herbert Samuel and
David Lloyd George, members of the
British Cabinet, and foremost in ad-
vocacy of the obnoxious measure, to
the surprise of the British public,
these accused members chose Sir Ed-
ward Carson and Mr. F. E. Smith,
another Conservative member, as
their lawyers in the case.

Could these bitter parliamentary
opponents be expected to look with
unprejudiced eyes upon the conduct of
the accused, and could the accused
expect fair play at the hands of such
bitter political opponents? These are
questions which have been troubling
many of the British people, and have
been answered in different ways.

It is, however, greatly to the credit
of both professions, the parliamen-
tary and the legal, that men highly
sensitive to their honor, and conscien-
tious of integrity, could willingly
put their case in the hands of men
with whom they were politically
speaking, at sword points, and that
the latter, accepting their briefs,
could virtually say to them, you can
trust us that our investigation of the
case will not be influenced by any
personal political considerations.

Such things make apparent the
high sense of honor and rectitude en-
tertained by and for the British bar,
and help as to a nobler view of our
fellowmen, even though, in many re-
spects, their opinions and actions
may be diametrically opposed to our
own.

We are in receipt of a paper on
The Housing Problem, read to a
large audience in the Technical Col-
lege, Halifax, on June 6th, by Mr.
G. Trafford Hewitt. This is a sub-
ject which is interesting philantrop-
ists in every land. The immigra-
tion into Canada of so many fam-
ilies from different parts of Europe,
large numbers of whom are disposed
to congregate in the cities, makes
this problem one of special import-
ance to Canadians at the present
time.

There can be no doubt that there
are slum districts in some of our
cities which rival in squalor and filth
anything to be seen in the home land
and make it almost impossible for
these occupying them to live clean
and wholesome lives and bring up
their families with habits and tastes
essential to good citizenship.

Mr. Hewitt purposes to visit sev-
eral of our principal towns to speak
upon this subject, and upon the
method of town planning for con-
venience and beauty. He is also in-
terested in an effort to bring English
capital into the province to be in-
vested in our various industries.

The Globe, referring to the state-
ment of Dr. Adams, of Montreal, that
the Fildesman consumption treat-
ment is, no doubt, a failure, adds,
"Healthy homes and workshops, pure
food and water, a living wage for all
workers, and reasonable time for
recreation would do more in ten
years to destroy the white plague in
our midst than all the combined ef-
forts of philanthropy at present
directed to its cure."
