

calculation, authorization and rate of stabilization payments to actual producers resident in Canada; to establish the Prairie Grain Stabilization Account in the Consolidated Revenue Fund; to provide for a levy to be deducted from all grain sale proceeds; to provide for refunds of over-payments of levy and for the payment of the amount of any deficit including interest of the Canadian Wheat Board relating to the grain and pool period that closed or closes on or after July 31, 1970; to establish an Advisory Committee and provide for the remuneration and expenses of the members; to provide during the fiscal year commencing on April 1, 1971 for special transitional payments in the aggregate amount of one hundred million dollars to actual producers resident in Canada and named in a permit book issued for the 1970-71 crop year before March 1, 1971; to provide that all moneys remaining in the Prairie Farm Emergency Fund be credited to the Prairie Grain Stabilization Account; and to provide for the repeal and amendment of certain related statutes and for matters incidental to the administration of the Act.
