Mr. Peters: Mr. Chairman, I am pleased that this debate is taking place today and I hope that something will come of it. I am aware of the fact that there is reluctance on the part of many members to get involved in this particular discussion because of the limitation which is put upon us by our rule relating to the 30 day limit. If this parliament were to concentrate only on that particular subject and was able to do something about it, then they would probably win the eternal gratitude of many of the people of this country.

I think this matter has been raised by a number of persons who have strong personal feelings about the increase in the cost of living which has a detrimental effect on a very large segment of our Canadian population. It is interesting to look at the person who raised this subject. He is a member who comes from an area where the average income is not very high. His knowledge of the farming problem in his area is considerable, and he knows that as the cost of every commodity rises his people suffer from it establishment.

I myself know of people who have been able to go to a doctor because of the present medical insurance plans, have been given a prescription and then could not afford to buy the drugs.

> Anyone here who has had a cold is well aware of the fact that when one goes to a drugstore to fill a prescription to fight off the effects of flu which has been prevalent in Ottawa, the bill for the 12 pills prescribed by the doctor will be anywhere from \$6 to \$12. This is away beyond the reach of many of those who are similarly afflicted and cannot afford drugs.

> I am sure the Minister of Finance is interested in this problem. I am quite prepared to give him the benefit of the doubt-and it is doubtful at present, because we are not familiar with what he is really doing in this matter. I really think he is not the finance minister of this country at all. I do not think we have had a true finance minister for years. It is the establishment which runs the Department of Finance in Ottawa. This is a fact. I think it is also true of the other departments concerned with consumer affairs. I am positive that the minister has been advised that the interest rate on bank loans should be increased, and I am sure that this advice was given to him by the establishment. I am also aware of the fact that his caucus told him that if he did this, he would have to look for another job.
