1. Has the Department of Regional Economic Expansion, under the Regional Incentives Act, authorized or provided an incentive grant to Transcan Custom Homes Ltd., Kenora, Ontario and, if so, what is the amount of the grant.

2. What is the total estimated cost of the project for which the grant was provided and what is the nature of the project and its location?

3. Who are the directors and chief executive officers of Transcan Custom Homes Ltd. and what is the address of each?

4. To what extent is this company non-resident or foreign-owned or controlled?

5. What is the name and country of the known non-resident ownership in this company?

**Mr. Yves Forest (Parliamentary Secretary to President of the Privy Council):** I am informed by the Department of Regional Economic Expansion and the Dominion Bureau of Statistics as follows: 1 and 2. This information was contained in the monthly report, tabled in Parliament on the operation of the Regional Development Act.

3., 4., and 5. Transcan Compact Homes Ltd. was incorporated in Ontario April 29, 1968. The corporate name was changed to Transcan Custom Homes Ltd., September 22, 1969. They have not yet been required to file the appropriate returns under the Corporations and Labour Unions Returns Act from which the answer to the question might be derived by virtue of recent incorporation.

#### Question No. 1,493—Mr. Stewart (Marquette):

1. How many recipients of Old Age Security in the present fiscal year have had their cheques

garnisheed by the Department of National Health and Welfare to recover benefit payments under the Act which they decided they were not entitled to, and in how many of these instances was (a) the total amount of the Old Age Security pension garnisheed (b) more than 50 per cent of the Old Age Security pension recovered by the Department?

2. In the fiscal years 1967-68 and 1968-69, what were the totals and what number in each year had to forfeit (a) the total pension (b) more than 50 per cent of their Old Age Security cheques?

**Hon. John C. Munro (Minister of National Health and Welfare):** 1 and 2. Old Age Security statistics are not maintained in such a way as to make it possible to provide this information.

**Mr. Paproski:** Mr. Speaker, I rise on a point of order. You have asked us to put many of our questions on the Order Paper. We have complied with your request and have done so. I notice that today there are about 116 pages of unanswered questions, constituting a booklet about as thick as the Ottawa telephone directory. I am told the number is the largest in 20 years. 1. Has a proposed budget been submitted by the Province of Prince Edward Island to the Government of Canada with respect to moneys required for the fiscal year 1970-71 under the Development Plan?

2. What are the details proposed in the budget submitted by the Province?

3. Has the whole or any part of this proposed budget been approved by the federal government and, if so, what are the details of the projects approved?

No, but a proposed budget has been submitted for the approval of the government of Canada and the province of Prince Edward Island by the joint federal-provincial advisory board for the Prince Edward Island plan.
