**CONSUMER AFFAIRS****INCREASE IN PRICE OF FOOD—REQUEST FOR INVESTIGATION TO DETERMINE WHETHER HIGHER PROFITS OF CHAIN STORES JUSTIFIED**

**Mr. T. C. Douglas (Nanaimo-Cowichan-The Islands):** May I direct a question to the Minister of Consumer and Corporate Affairs, Mr. Speaker. On Wednesday, as reported on page 2352 of *Hansard*, I asked the Acting Prime Minister if the government was investigating the fact that food prices are rising at a time when food chain stores are showing very substantial increases in profits, and the Acting Prime Minister's answer was in the affirmative. I therefore want to ask the minister whether these investigations are being carried on, whether he intends to report to the House the results of these investigations, and when we may expect such a report?

**Hon. Robert K. Andras (Minister of Consumer and Corporate Affairs):** Mr. Speaker, I believe I responded to a similar question from another member of the hon. gentleman's party the other day. I will repeat my answer to the extent of saying that if any violations of the Combines Investigation Act are brought to the attention of the director of the anti-combines section they most certainly will be investigated, but that has not occurred yet.

**Mr. Douglas:** In view of the fact that the Department of Consumer and Corporate Affairs is supposed to protect consumers and that there are very sharp increases in the prices of food coincidental with sharp increases in profits by the companies selling food, will the minister himself undertake to instigate an investigation into this matter to see whether or not there is any collusion among the companies or whether exorbitant profit-taking is going on?

**Mr. Andras:** That would properly fall under the purview of the director of the combines investigation section, and if there is any evidence of this kind of action taking place I am sure he will carry out his duties in that regard.

**REQUESTS FOR INVESTIGATION OF HIGHER FOOD COSTS IN YUKON THAN IN YELLOWKNIFE**

**Mr. Erik Nielsen (Yukon):** My supplementary question is for the Minister of Consumer and Corporate Affairs.
