DEVELOPMENT OF MANAGEMENT COURSES PROGRAM

# Question No. 177-Mr. Rodriguez:

1. What were the names of the recipients of grants under the Development of Management Courses Program (DMC) in each of the fiscal years 1968-69, 1969-70, 1970-71, 1971-72, 1972-73 to date, and what were the amounts in each case?

2. What are the objectives of the above program?

3. Has the department conducted any evaluative study of the program and, if so, what was the date of the latest report?

Mr. Herb Breau (Parliamentary Secretary to Minister of Industry, Trade and Commerce): 1. The Development of Management Courses program was initiated in 1972 and the contributions approved to January 4, 1973 (Fiscal Year 1972-73) are as follows: Society of Industrial Accountants of Canada, \$50,000. Ontario General Contractors Association, \$17,250. Mechanical Contractors Association, Ontario, \$29,250. Montreal Dress and Sportswear Manufacturers' Guild, \$5,000. Canadian Institute of Management, \$22,000. Mechanical Contractors Association, Toronto, \$21,000.

2. To encourage the improvement of management of managerial competence in Canadian industry by assisting associations to develop or revise management retraining or upgrading courses of high quality. Care is exercised that the program does not contribute to an undesirable proliferation of courses.

3. The program is under continuous evaluation and review.

Mr. Herb Breau (Parliamentary Secretary to Minister of Industry, Trade and Commerce): Statistics Canada reports that: Information on the book profits, taxable incomes, federal income taxes and provincial income taxes reported by corporations for 1970 distributed by asset size and control is not, at present, available. However, it will be included in the annual report under the Corporations and Labour Unions Returns Act (Part 1, Corporations) for 1970 to be tabled in the near future.

Mr. Herb Breau (Parliamentary Secretary to Minister of Industry, Trade and Commerce): In so far as Statistics Canada is concerned: Figures are not yet available for 1972. However, data are provided below for 1971. 1. In 1971 there were 100 homicides committed with rifles.

2. In 1971 there were 54 homicides committed with restricted weapons.

3. In 1971 there were 233 homicides committed by methods other than shooting.

4. Statistics Canada does not collect this information.
