SUGGESTION GOVERNMENT RESPECT JURISDICTION OF EACH PROVINCE—MOTION UNDER S.O. 43

Mr. Claude Wagner (Saint-Hyacinthe): Mr. Speaker, under the provisions of Standing Order 43, I request the unanimous consent of the House to bring up an urgent matter of national importance.

In view of the increased tensions and obvious economic and social injustices which were provoked by the present government through faulty application of the principles of Canadian federalism, more specifically as regards decentralization, respect for provincial autonomy and bilingualism, I move, seconded by the hon. member for Hochelaga (Mr. Lavoie):

That this House demand of the government that it prove itself responsible by putting an end to its tactics of systematic harassment and confrontation, and that it come back to the only true concept of the federal pact, namely an integral respect of the jurisdictions of each province, the essential guarantee of harmony in Canada.

Mr. Speaker: The House has heard the motion of the hon. member. Under the terms of Standing Order 43, the motion requires the unanimous consent of the House. Is there unanimous consent?

PROPOSAL TO CHANGE RESPONSIBILITIES OF MINISTER OF TRANSPORT
